Compliance Self-Assessments

The Aged Care Quality and Safety Commission (the Commission) recommends aged-care providers “undertake ongoing internal performance reviews against each of the Quality Standards”.

Providers must ensure all applications for re-accreditation include a recent compliance self-assessment which the Commission can request at any time, including during announced audits.

Continuous Improvement Planning

In addition to undertaking regular compliance self-assessments the Commission requires aged-care providers to have a written and up-to-date plan of continuous improvement (PCI).

Providers are also required to revise their PCI when the Commission has made a decision regarding their non-compliance with the Quality Standards.

Commission Templates

To assist providers with their compliance self-assessment and PCI obligations the Commission has made available two MSWord® templates.

Unfortunately, using MSWord® templates to manage and coordinate self-assessments and PCI's across multiple homes and services can be a very time consuming and sometimes frustrating task. This is where Compliance Master® can help.
